Current COVID Investigations

March 15, 2021

One student tested positive for COVID-19 at Flatwoods Elementary. Student not onsite since Thursday. Contact tracing was conducted and no additional individuals are required to quarantine.

March 15, 2021

One athlete tested positive at BCHS for COVID-19. 25 students/athletes and one staff member are required to quarantine.

February 23, 2021

One student tested positive for COVID-19 at BCMS. Contact tracing led to the quarantine of 4 additional students.

February 22, 2021

One student and one staff member tested positive at Braxton County High School for COVID-19. 8 additional individuals were identified for quarantine.

February 16, 2021

One individual tested positive at Burnsville Elementary. The individual had not been on site since the previous Wednesday. No additional individuals were identified to quarantine.

Janaury 26, 2021

One individual tested positive at Flatwoods Elementary. The individual has not been at school since Friday, January 22. The school health staff was consulted along with Health Department. Two additional staff were identified for quarantine.

One student tested positive at Braxton County Middle School over the weekend. The student was last at school on Thursday, December 3, 2020. Contact tracing has been conducted by the school in cooperation with the district's nursing staff and the Braxton County Health Department. As a result, 9 additional students from BCMS are to quarantine. 3 students at Flatwoods Elementary, who were contacts on the bus, are to quarantine.

December 4, 2020

One student tested positive at Burnsville Elementary. Student was last at school on 11/19/20. Contact tracing at the school was not necessary in this situation.

December 3, 2020

One staff member tested positive at Braxton County High School. The individual was at school Thursday, December 3, 2020. Contact tracing has been conducted by the school in cooperation with the district's Nursing Staff and the Braxton County Health Department. As a result, 7 additional people have been asked to quarantine after coming into direct contact with the individual who tested positive. BCHS is closed on Friday, December 4, 2020.

December 1, 2020

One individual tested positive at Burnsville Elementary. Contact tracing was conducted by the school in cooperation with the Braxton County Health Department. As a result, no additional persons are required to quarantine. Braxton County Schools are currently under the Remote Learning order of Governor Justice through December 2, 2020.

November 30, 2020

One individual tested positive at Braxton County High School. Contact tracing was conducted by the school in cooperation with the Braxton County Health Department. As a result, 1 additional person is quarantined. Braxton County Schools are currently under the Remote Learning order of Governor Justice.

November 27, 2020

One individual tested positive at Braxton County High School. This occurred during Thanksgiving Break. No additional individuals associated with the school were required to quarantine. Braxton County Schools are currently under the Remote Learning order of Governor Justice.

November 12, 2020

One individual tested positive at Braxton County High School. The individual was last at school on Thursday, November 12, 2020. Contact tracing was conducted by the school in cooperation with the district's nursing staff and the Braxton County Health Department. As a result, 5 additional persons were quarantined. BCBS remains open.

October 27, 2020

One individual tested positive at Braxton County Middle School. The individual was last at school on Friday, October 23, 2020. Contact tracing was conducted by the school in cooperation with the district's nursing staff and the Braxton County Health Department. As a result, no additional persons were quarantined. BCMS remains on remote learning for the week.

October 27, 2020

One individual tested positive in the central office. Contact tracing was conducted in cooperation with the district's nursing staff and the Braxton County Health Department. As a result, three additional people have been asked to quarantine. Central Office is closed Wednesday, October 28, 2020 for cleaning and disinfecting.

October 19, 2020

One individual tested positive at Braxton County High School for COVID-19. The individual was last at school Wednesday, October 14, 2020. Contact tracing has been conducted by the school in cooperation with the district's nursing staff and the Braxton County Health Department. As a result, one additional person has been asked to quarantine. The school remains open.

October 18, 2020

Four individuals at Braxton County High School have tested positive for COVID-19. The individuals were last at school on Wednesday, October 14, 2020. Contact tracing has been conducted by the school in cooperation with the district's nursing staff and the Braxton County Health Department. As a result, 19 additional people at the school are required to quarantine after coming into direct contact with the confirmed case. Braxton County High School will resume on Monday, October 19, 2020.

October 18, 2020

One individual at Braxton County Middle School is suspected of being positive of COVID-19 after an Antigen Rapid Response test. The individual last attended school on Wednesday, October 14, 2020. Contact tracing has been conducted by the school in cooperation with the district's nursing staff and the Braxton Health Department. As a result, 5 additional people at the school have been asked to quarantine after coming into direct contact with the ill individual. The school remains open and on a modified schedule.

October 14, 2020

Braxton County Schools has confirmed one positive diagnosis and two probable cases at Braxton County High School. The case includes three students and no faculty or staff members. For the health and safety of all students and faculty, the school will begin distance learning on Thursday, October 15, 2020. All high school athletics and extracurricular activities will be suspended immediately. The school system will work closely with the Braxton County Health Department to conduct contact tracing over the next couple of days. We will evaluate and notify families of next steps by Sunday, October 18, 2020.

October 8, 2020

An individual at Frametown Elementary has tested positive for COVID-19. The individual was last at school Thursday, October 8, 2020. Contact tracing has been conducted by the school in cooperation with the district's Nursing Staff and the Braxton County Health Department. As a result, 12 additional people have been asked to quarantine after coming into direct contact with the individual who tested positive. Frametown Elementary remains open.
